PROFILE

He is a Member of the selection committee of the IV Entry Exam for Appeal Courts. He was Coordinator of the Lisbon Section of the Católica Research Centre for the Future of Law and of the doctoral programmes of the School of Law of the same Faculty, from 2013 to 2014. He is currently National Dean of the Faculty of Law of the Portuguese Catholic University and was a Member of the Governing Board, from 2002 to 2005. He was Of Counsel at the law firm «Ferreira Pinto & Associados», from 2004 to 2007. He was a Member and Secretary of several legislative committees, special mention going to the Revision of the Criminal Procedure Code (revision introduced by Law No. 59/98, of August 25).
